I/We, the undersigned, being the Parent(s)/Legal Guardian(s) of the above applicant, request that Ambrose Treacy College accepts him as a student in the year of entry and for the class indicated above. In consideration of the College's acceptance, I/We undertake and agree to the following conditions upon which the offer was made:

- I/ We seek a Catholic education for my/our son(s) and I/We support the Christian values
  of the College, the religious education and other College initiatives that actively espouse
  and promote Christian and Edmund Rice values. I/We understand that while my son is a
  student at the College he is expected to support and take part in these faith activities
  and respect the religious principles and practices of the College and that failure to do so
  could lead to cancellation of enrolment.
- 2. In accepting the offer, I/We also accept that my/our son is admitted to the College on the condition that he will abide by the College rules and policies including those regarding curriculum, behaviour, acceptable use of technology, dress and well-being and that I/We will support these reasonable College expectations and policies in these matters in the interest of the wellbeing of all the students and staff.
- 3. In this support I/We will keep the College indemnified against any loss or damage caused by any failure of my/our son to observe para.2.
- 4. It is accepted that, unless in exceptional circumstances, during the time my/our son attends the College he will live in the care and control of his family and that proposed changes must be notified to the College.
- 5. I/We will work in partnership with the College in the best interests of my/our son and all other students.
- 6. I/We acknowledge the educational expertise of the College and will support educational initiatives for my/our son.
- 7. I/We agree that the College Rules, Code of Behaviour and Policies may be altered or added to at any time.
- Fees and levies will be paid at the time determined by the College and will remain payable during any period of absence of my/our child from the College unless otherwise agreed.

- 9. I/We will contact the College promptly if there is any change about fee-paying arrangements or concern that I/We may not be able to pay the fees as contracted and make further arrangements as to how any resulting debt will be paid.
- 10. I/We acknowledge that unless otherwise agreed in writing with the College, I/We as parents or guardians are jointly and severally liable for the payment of fees and levies. Should any fees or levies not be paid by the due date, and no further arrangements / adjustments made for payment, then the College may, in its sole discretion, suspend or terminate the applicant's enrolment at the College and take legal action to recover outstanding fees and levies.

- 11. If the applicant is to leave the College, I/We will, where possible, give written notice:
  - a) not later than the first day of the term at the end of which it is intended he is to leave; or
  - b) if it is intended that he should leave during a Term, not later than the first day of the preceding term. If I/We fail to provide notice in accordance with the aforesaid requirements, the College reserves the right to invoice me/us for one term's fees.
- 12. I/We consent to my/our son participating in all normal curricular, sporting and extracurricular activities conducted with the approval of the College, such as College camps, excursions and functions.
- 13. With reference to the above, or in the case of an emergency not covered by the above, I/We consent to my/our son travelling by College bus, or on any form of public or private transport, where such transport is deemed, in the reasonable opinion of the College, to be necessary or desirable.
- 14. In the event of any medical or other emergency arising in which the College considers it impossible or impractical to communicate with the undersigned Parent/s or Guardian/s, I/We accept and give consent that the College will take all reasonable care for my/our son in the event he experiences an accident or illness and acknowledge that the College will not be responsible for the costs of any medical or dental attention or treatment administered to the my/our son in such event, nor will it be responsible directly or indirectly for any act or omission of any medical or dental practitioner or medical officer attending or treating my/our son, including attention provided by the College staff.
- 15. This consent (para 14) which I/We have given is valid at all times while the student is in the custody of the College, including but not limited to, such times as my/our son is on campus, is present at College camps or is attending or participating in an excursion, function, sporting or cultural activity.
- 16. The Principal, or delegate/nominee, has authority to apply whatever disciplinary measures are appropriate or necessary in relation to the conduct of my/our son, both inside the College and at outside College related events. This includes behaviour whether inside or outside the College that might bring the good name of the College into disrepute and may include the decision to suspend/exclude/expel my/our son for any cause judged to be sufficient. I/We acknowledge that the College is required by law and pursuant to the College Student Protection Policy to contact Queensland State Authorities in cases of harm to or sexual abuse of students.
